STORMWATER

- 54 identified projects: four are under design, three are in contract development, five in easement acquisition, two in technical review, three in scope development, and the remaining pending final invoice or inspection.
- Five new stormwater work requests received.
- Details on specific projects with activity during reporting week below:
 - 70 Seville Chase (Construction) Pipes and structures will be lined or replaced. Utility coordination underway with Fulton County to replace degraded sewer line in conjunction with construction. Construction progressing as planned. A change order is under review. Undermined CMP pipe was filled with lean concrete.
 - 435 Pine Forest Road Phase II plan development completed. Construction started April 1. Stormwater junction box installed. Restoration work is underway. Consultant preparing grading alternatives to complete project. Contractor preparing a change order for project site restoration. Approved change order and completed re-grading the project limits. Fine grading completed. Sod placement and final stabilization underway.
 - 4878 Long Island Drive (Pre-construction) Project consultant prepared plans to replace a deteriorating end wall along Long Island Drive just outside the right of way. Discussion with impacted homeowners continues. Construction continues. Clearing completed. First stormwater junction box installation completed. Drainage pipes installed. Fill placement is underway.
 - 821 Tanglewood/4825 Jett Road (Pre-construction) A pipe will be replaced under the road. Working remaining easements. Installation of needed stormwater piping is ongoing. Downstream work completed. Junction box installed. Remaining pipe laying task is underway.
 - 7275 Twin Branch Road Stormwater system has failed and must be replaced. The project is in condition review and concept phase. Concept level designs completed. An updated easement document sent to affected property owner for signature. Plans submitted for permit. Awaiting easement donation. Project placed on hold until legal clarification received.
 - 5690 Lake Forrest Drive A depressed area in front yard is under investigation. Soil testing/sampling completed. Written report including recommendations received. Coordination with the property owner is underway. Purchasing has published the request to bid. Bidder questions answered. Bid received and lowest bid selected for award.
 - 7236 Thornhill Lane Existing Conditions Assessment Study kicked off and ground run survey completed. Received cost proposal for additional study. A change order request is routing for approval. Awaiting Purchase order approval.
 - 980 Crest Valley Road The design project will correct streambank erosion near a pipe end. A
 headwall will be designed and other repairs will be engineered. Conceptual plans were reviewed and
 approved. Construction documents received. Plans submitted for permitting. Plans approved for
 construction. Project is moving to bid phase. Project is in open bid phase.
 - 140 Landsdowne Drive The design project main objective is to rehabilitate the deteriorating stormwater system located between 120 and 140 Landsdowne Drive. The site investigation report has been prepared and approved. Consultant submitted Concept Plans and Stormwater Report for review and approval. Reviews were completed and comments noted. Construction plan preparation phase initiated.

RECREATIONAL & CULTURAL ENRICHMENT

PROJECTS

- Allen Road Park: Substantial Completion established with designers site review and punchlist this week. Contractor working on short list of needed corrections; primarily plant replacement.
- Hammond Park: Erosion Control Project: The retaining wall above the gym has been poured. New sidewalk from Hammond Drive into the east parking lot is near completion.
- Hammond Park Field Turf Replacement: Additional funds have been authorized to purchase a pad to be
 installed under turf and replace the fields' collector pipe system. Staff is preparing a change order to the
 contract.
- Overlook Park Streambank Restoration Project: The designer presented a revised concept plan to Community Development. Requested adjustments have been made and are returned to Community Development for supplemental review. Permit requests to various state and federal entities will follow.

SUSTAINABILITY

- Sustainability staff is developing the planting plans with Trees Atlanta for the upcoming season.
- Sustainability and GIS staff are updating the tree survey and story map.
- Sustainability and Planning and Zoning staff wrapped up the text amendments to allow public trails in stream buffers, and to update the restoration standards, approved by Mayor and Council on June 15.
- Sustainability staff toured a demonstration project on the River Lands regional trail network, June 13.

TSPLOST PROGRAM

- TS-103 Spalding/Dalrymple/Trowbridge Intersection Improvement Project: Project is complete.
- TS-105 Roswell Road at Grogan's Ferry Road Intersection Improvement: Initial traffic control installed.
 Clearing and grubbing complete. Georgia Power overhead line relocations have begun. Grading work underway.
- TS-106 Northside Drive at Riverview/Old Powers Ferry: Right of way acquisition underway. Final plans complete. Overhead utility relocation coordination ongoing.
- TS-107 ATMS 4 SCOOT Implementation in the Perimeter Area: All fieldwork is complete. Equipment detection validation and system tuning underway with final walk-through completed.
- TS-108 Roswell Road at Dalrymple Road: Final plans are complete. Right of way acquisition is underway.
- TS-111 Spalding Drive at Pitts Road: Right-of-way acquisition efforts are beginning with right of way staking completed. Utility coordination ongoing. Final plan production ongoing.
- TS-166 Spalding Drive Widening Project: Winters Chapel Road to Holcomb Bridge Road: Georgia Power Company installed new poles to relocate facilities. The construction contractor (administered by Gwinnett County) is advancing new roadway and bridge construction with bridge and roadway widening work currently underway.
- TS-167 Brandon Mill Sidewalk from Marsh Creek to Lost Forest: Council approved award of a new construction contract contingent upon the outcome of negotiations with the former contractor. As a resolution is determined, we will provide updates on the revised timetable and activity schedule. The construction site has been temporarily secured pending resolution.
- TS-168 Dalrymple Road Sidewalk (Princeton Way to Duncourtney Dr.): This segment will provide sidewalk on at least one side of the road along Dalrymple from Roswell Road to Brandon Mill Road. Design is underway. Construction planned to begin late 2021.
- TS-169 Dunwoody Club Drive Sidewalk from Spalding Drive to Fenimore Circle: Design work, advance utility relocations and right of way acquisition are nearing completion. Construction planned to begin this month. Anticipated construction duration is six months. Motorists advised to expect ongoing lane closures.
- TS-170 Interstate North Parkway Multi-use Path (Northside Drive to the Chattahoochee River Bridge): Construction contract awarded with construction planned to begin this month. Anticipated construction duration is seven months. Motorists advised to expect ongoing lane closures.
- TS-171 Roberts Drive Sidewalk from Northridge Road to Davis Academy: Construction to include current stormwater work with ongoing lane closures is underway as of March 2021. Construction completion scheduled this Summer. Motorists are advised to expect ongoing lane closures.
- TS-172 Brandon Mill Road Sidewalk (Lost Forrest Drive to Brandon Ridge Drive): This sidewalk segment will complete a sidewalk network connecting the length of Brandon Mill Road from Dalrymple Road to Abernathy. Design is underway. Construction planned to begin early 2022.
- TS-191 Mt. Vernon at Johnson Ferry Improvements: Staff is coordinating with Georgia Power Company to advance plans and schedule for the relocation of transmission poles at Mt. Vernon Highway and Roswell Road and undergrounding of aerial utility services in the area from Roswell Road to Hilderbrand on both Johnson Ferry and Mt. Vernon Highway. Coordination for Transmission Preliminary Engineering subsurface activities is underway. Right-of-Way Acquisition is underway.
- TS-192 Mt. Vernon Highway Corridor Improvements: Development of Final Plans and Drainage Report is ongoing. Stormwater design has been completed and is in review by City of Atlanta Water Department. Coordinating agreement with PCID to fund east of Barfield to Abernathy ROW Acquisition and Construction (\$2.85M). Right of way acquisition efforts are underway.

CAPITAL IMPROVEMENT PROGRAM (CIP)

- T-0019 Roswell Road Streetscapes (East Side City Limit to I 285. West Side City Limit to Long Island):
 This federally-funded, MARTA sponsored project is advancing with concept design work underway. Field
 survey work is underway.
- T-0033-7 CDBG Sidewalks Roswell Road Streetscape from I-285 to Long Island: Sidewalk construction is near completion with work underway north of the intersection of West Belle Isle Drive and Roswell Road. Currently awaiting utility relocations to complete work and then install pedestrian scale street lighting. In advance of lighting installation, the Lighting Agreement with the Georgia Department of Transportation has been approved by Mayor and Council.
- Phase 2 of the project from the Prado (Lake Placid Drive) to I-285 is currently in right of way acquisition and utility coordination. Phase 2 construction is planned for late 2021.
- T-0035 Roswell Road Bicycle/Pedestrian Bridge over Chattahoochee River: This project is being delivered through cooperation with the City of Roswell and the Georgia Department of Transportation. The Atlanta Regional Commission has approved sufficient funds to support the estimated construction cost of the project.
- T-0043 Glenridge Drive @ Roswell Road Intersection Realignment: This construction project is administered by the Georgia Department of Transportation (GDOT). Construction activity has ceased temporarily while GDOT and City of Atlanta Watershed coordinate completion of waterlines impacting construction. Although currently delayed, GDOT forecasts the project to be completed August/September 2021.
- T-0058-1 Boylston Drive Streetscape and Hammond intersection realignment: This project will complete streetscape improvements between Hilderbrand Drive and Hammond Drive and realign the intersection at Hammond to improve traffic efficiency. Concept design is currently underway. Right-of-way acquisitions and utility coordination are scheduled to begin in 2022 and construction is anticipated to begin in 2023.
- T-0060 SR 400 Multi-Use Path: GDOT has received the City of Sandy Springs' executed Contract for Acquisition of Right of Way. Expecting ROW Acquisition Notice to Proceed (NTP) from GDOT June 14. Geotechnical investigation borings for the wall areas (WFI) and bridge areas are complete.
- T-0064 Peachtree Dunwoody at Telford Roadway Improvements Project: This project provides safety enhancements along the road near the intersection. Right-of-way acquisitions and utility coordination are nearly complete with construction planned to begin Fall 2021.
- T-0067 Mt. Vernon Highway/Dupree Intersection upgrade: The project will upgrade signal infrastructure to meet current standards and will include decorative poles and mast arms. Construction bids are due this month with construction planned to begin Fall 2021.
- T-0069 Peachtree Dunwoody at Windsor Parkway Intersection Project: This project provides safety and operational improvements at the existing intersection. Right-of-way acquisition and utility coordination are underway. Construction planned for Fall 2021.
- CC-0010 Sandy Springs Circle Streetscape Hammond to Mt. Vernon Hwy: Lighting installation continues
 this week. Storm drainage system installation is underway with work on major side slopes and retaining
 walls underway. Lane shifts and ongoing lane closures are in use along Sandy Springs Circle. The project is
 forecasted to be completed by August 2021.

TRANSPORTATION/TRAFFIC

- The Georgia Smart Communities project with the Georgia Institute of Technology continues. The City of Sandy Springs, in partnership with the City of Dunwoody, MARTA, and Georgia Tech researchers, submitted a proposal in June 2020 for a grant to "Streamline Suburban Transit" to improve the transit experience for existing and future riders. The project will leverage existing infrastructure to test transit signal priority (TSP) technology using bus location data published through an application program interface (API) instead of communicating with a unit on board the bus. The results of this study will inform how TSP could be implemented in the City in the future. The Georgia Smart grant was announced in early August, and Sandy Springs was awarded a grant of \$75,000 from the Atlanta Regional Commission to undertake the project. The City's match for the grant is \$18,750, for a total of \$93,750. The project is currently testing Transit Signal Priority operations on the MARTA Route 5 in the Hammond Drive and Roswell Road corridors. The project has funded two interns to work with City staff on the project, and the interns started work in May.
- The Transportation Department is working with neighbors in Whitner/Idlewood, Wyndham Hills, Huntcliff, Glenridge-Hammond, Jett Road, and Glen Errol on traffic calming initiatives. The City's Adopted Traffic Calming policy is a neighbor-driven process to calm traffic on neighborhood streets. http://www.sandyspringsga.gov/city-services/transportation-infrastructure/traffic-calming

- The Traffic Department is continuing the engineering analysis and design for short-range improvements and long-range alternatives to address ongoing safety concerns at the Roswell Road/SR 9 at Abernathy Road intersection.
- The Traffic Management Center is upgrading back-up power systems for 30 signalized intersections. There may be brief, intermittent signal outages (i.e., signal in flash or signal dark) during construction. The project is 75% complete.
- The Traffic Department is undertaking a concept study at the Intersection of Mt. Vernon Highway and Long Island Drive under the Intersection Operations and Safety Program. Concept development is underway.
- The Traffic Management Center is upgrading Vehicle Approach Warning Flashers (VAWF) at the following locations: Dunwoody Club Drive and Chaparral Pl, High Point Road and Bransford Road, Lake Forrest Drive and Burdette Road, Powers Ferry Road and Carol Lane, on Carpenter Drive, Riverside Drive and Wildercliff Drive, and Riverside Drive and Pointe Ridge Drive. The project will continue through the early summer.
- The City's Striping Contractor has initiated pavement marking maintenance activities. All striping for the current fiscal year will be completed by June 30. The following locations are identified for refreshed pavement markings:

- Responded to 301 calls: Two Fires, 95 EMS, 35 Service, 137 Good Intent, 21 False Alarms
- Units responded to reports of a vehicle fire in the 1000 block of Johnson Ferry Road. Crew arrived to find three cars on fire on the third floor of a parking deck with heavy black smoke. Personnel stretched a 1.75" hose line for fire control. Crewmembers successfully extinguished the fire and requested a fire investigator to examine the fire.
- Units responded to reports of a possible structure fire with reported wires arcing in the 5500 block of Glenridge Drive. Upon arrival, the resident stated the furnace was smoking and there were sparks coming from the water heater. Personnel found an air conditioner unit frozen with scorch marks on the ice. Crewmembers were unable to locate the source of the sparks. Crew found no elevated temperatures of the surrounding areas with the thermal imaging camera. The water heater was located behind the door of a bedroom immediately on the left upon entry. Personnel witnessed no sparks from the water heater however water from the air conditioning unit appeared to be leaking down onto the water heater. Crew shut down power to the unit and found no elevated temperatures with the thermal imaging camera. No smoking or arcing found on scene. Personnel contacted building maintenance for emergency repairs.
- Units responded reports of a car striking a building in the 900 block of Crestline Parkway. On scene crewmembers found a pillar to the front hotel lobby had been struck. The vehicle had left the scene. No injuries were reported. Personnel wrapped the outside lobby area in caution tape and locked the doors to the lobby. Crew advised guests advised to use a side entrance for the hotel. Crewmembers requested a Sandy Springs structural engineer to assess the damage.
