RECREATION AND PARKS PROJECTS

- Allen Road Park improvements: The City has accepted the project as complete and issued an Acceptance Letter to the contractor. Some plant material will need replacement this fall while under warranty.
- Hammond Park Erosion Control: The liner and border stone have been installed to wrap and armor the step
 pool features in the cove between the gym and the Round Building. Stair and bridges have been constructed.
 Most of the trail border is complete with stone material installed for future pedestrian use. A temporary work
 stop order has been issued to rectify erosion control and tree saving requirements. Rain has been a factor
 this week in completing some of the remaining project elements.
- Georgia Power met with staff to discuss their recommendation to replace the transformer on the south side of the Hammond Park tennis courts that powers the lights there. The utility is working on options to move the transformer to another location. A proposal is forthcoming.
- Hammond Turf Replacement: The contractor has concluded installation of the collector drains and has finished grading the field in advance of the pad and turf replacement installation. A date for installation has not been provided.
- Ison Springs Elementary IGA Improvements: The pavilion for the basketball court area is on order.
 Landscaping activities at the playground and areas adjacent to the back of the school building are forthcoming.

SUSTAINABILITY

- The Flood Mitigation and Resilience Plan project kicked off on July 16.
- Sustainability Staff is supporting Emergency Preparedness with the update of the Hazard Mitigation Plan.

LANDSCAPE

The resident stated that she noticed an odd smell about 30 minutes prior and was worried there may be a gas leak. Personnel found no abnormal readings on the gas monitor. Further investigation of the surrounding apartments revealed the cause of the odor to be use of paint thinners in an adjacent apartment. Crew ventilated the resident's apartment and notified her of the cause of the odor.
- Units responded to reports of a reported tree down in the roadway blocking two lanes on I-285 Eastbound before Northside Drive. Upon arrival with SSPD, fire personnel blocked two lanes. Crew found a passenger vehicle parked on the right shoulder after colliding with a portion of the tree. No injuries were reported, and a tow truck was requested. Personnel used the chain saw to cut up and remove a large tree. Crew moved all debris to the right shoulder.
