PROJECTS

- Allen Road Park improvements are complete and plantings will be reinstalled in the fall. At the City's request, the contractor left the tree save fence around the rain garden to establish the lawn before opening it to pedestrian traffic.
- Hammond Park Erosion Control Project border installation for crushed stone trail network continued. Bridge work in two locations has started. Georgia Power will meet to discuss needed access to replace a transformer behind the tennis courts.
- Hammond Park Turf Replacement on the multi-purpose field concluded installation of collector drains on the south and north sides of the field. Spoil material from the trenches has been removed and stone will soon be spread and to ensure positive drainage.

SUSTAINABILITY

- Candidates for the sustainability internships were selected for the upcoming academic year.
- Sustainability staff is preparing to host the August Southeast Sustainability Directors Network's podcast.
- Staff from several departments are discussing potential uses for the Tree Fund.

LANDSCAPE

- Responded to 284 calls: Nine Fires, 92 EMS, 27 Service, 136 Good Intent, 14 False Alarms
- Units responded to reports of a dumpster fire in the 7600 block of Roswell Road. Crewmembers arrived on scene to a fully involved 30-yard dumpster fire filled with construction trash. Personnel attempted to extinguish with a 1.75" line with foam on tank water. Crew used a ladder to flood the container and extinguish the fire.
- Units responded to reports of a dumpster fire in the 5500 block of Glenridge Drive. Upon arrival, crew found a dumpster with flames showing. Personnel extinguished the fire with a 1.75" line using 500 gallons of water.
- Units responded to reports of a dumpster fire in the 6500 block of Roswell Road. On scene, crew found a dumpster in the rear of the complex that was smoking and had a small amount of burning garbage inside. Personnel extinguished the fire with a 1.75" hand line.
- Units responded to reports of a dumpster fire in the 8800 block of North Dunwoody Place. Upon arrival, crew found a large trash compactor heavily involved in fire. Personnel pulled one 1.75" attack line for extinguishment and applied foam. Crewmembers had to cut a hole in the roof of the compactor for total extinguishment.
- Units responded to reports of a structure fire in the 8300 block of Roswell Road. Upon arrival, crew found nothing showing from three sides. Upon arrival to second floor, personnel met with occupant standing in breezeway who stated that her boyfriend had set her clothes in the closet on fire. Upon entry to unit, crewmembers found smoke and heard an audible alarm. Crew found clothing smoking on the stovetop, which they removed from the stove and placed in a pot in the sink with water. Personnel disconnected the smoke detector inside the unit and removed it from the apartment to stop the alarm sounding. Further investigation found a shoebox in the bedroom floor that had been set on fire and was no longer burning. Crew bagged all the items and set them aside for the fire investigator. Crewmembers ventilated the structure using positive pressure ventilation.

INSPECTIONS

- There were 75 inspections conducted with 45 violations cited.
