SSFD OPERATIONS

- Responded to 317 calls: 3 Fires, 107 EMS, 25 Service, 133 Good Intent, 42 False Alarms
- Units responded to reports of a structure fire in the 8100 block of Colquitt Road. Upon arrival, crew found light smoke coming from the first floor unit. Personnel made entry through the rear door with a water can and were able to contain two spot fires. Crew also pulled a 1.75" attack line to the alpha side and completely extinguished the fire. Personnel found a tripped breaker in the electrical panel. Smoke damage was mainly contained to the living room, kitchen and hallway. Fire damage was confined to a worktable and the interior exposure D wall with minimum water damage.
- Units responded to reports of a dumpster fire in the 6300 block of Roswell Road. Crew arrived on scene to a small dumpster with a small amount of trash smoldering. Personnel used a water can to cool off and extinguish the contents. No other hazards remained.
- Units responded to reports of a vehicle fire on GA-400 north bound near Pitts Road. On scene personnel extinguished a fire that was involving approximately 50% of the vehicle with one 1.75" hand line. No occupants were in the vehicle at the time crewmembers arrived on scene. The vehicle was off the roadway and completely on the shoulder of the road when units departed the scene.
