## RECREATION AND PARKS

### PROJECTS

- The Hammond Park erosion control project major elements are complete. The design team and City engineers are in discussion on redesign solutions to better drain a few clogged step pools holding sediment.
- The opening of Hammond Park turf field has been very well received by the public. Waiting on goals, nets, and site furnishings to be shipped.
- Hammond Park Tennis court lighting has been restored.
- The Overlook Park streambank restoration project at the dock area is in the permitting phase. Army Corps permitting is complete. EPD and National Park Service permits are in progress. Community Development is assisting with the Metropolitan River Protection Act related issues.
- Staff toured four parks with Communications and GIS staff reviewing existing signage and discussing wayfinding sign progress and broader city-wide branding.
- Finishing plans with Boy Scouts of America and Eagle Scouts for projects to commence at Allen Road and Ridgeview Parks.

### **OPERATIONS**

Responded to 305 calls: 2 Fires, 96 EMS, 26 Service, 133 Good Intent, 35 False Alarms

- Units responded to reports of a transformer problem in the 100 block of West Wieuca Road. Upon arrival, crew observed a small fire on the ground beside the power pole. Personnel also observed parts of a blown transformer on the ground. Crewmembers used a dry chemical extinguisher to extinguish the fire and requested Georgia Power to be in route.
- Units responded to reports of people stranded on the Chattahoochee River. Units arrived on scene and deployed the boat to retrieve the victims. Crew retrieved two victims off the rocks in the middle of the river while two other civilians were retrieved on the bank. All victims were brought back together at the boat ramp. The civilians sustained no injuries.

### **INSPECTIONS**

- There were 89 inspections conducted with 45 violations cited.

### **SAFETY EDUCATION & PUBLIC RELATIONS EVENTS**

- SSFD oversaw four community events with 115 participants: Educate & Vaccinate, Fire Warden training and two First Aid training events.
