PROJECTS

- Hammond Park erosion control project design team and City Engineer are in discussion on redesign solutions to better drain a few clogged step pools. The contractor has completed all major elements.
- The Hammond Park turf replacement and drainage pad installation project has concluded with the job approved. The field opened to the public Saturday, September 11. Staff are on-site supervising field so that the public is made aware of the new posted rules.
- Georgia Power has replaced an ageing transformer south of the tennis courts responsible for court lighting. A lighting contractor will visit September 17 to energize the lighting for use.
- Staff met the Morgan Falls Overlook Park dock provider to review potential expansion and repositioning off shore. This is due to the dock's proximity to shore and river debris accumulating behind the dock.

- Completed the planting plans for Marsh Creek Rain Garden and Windsor Meadows for implementation in the fall.
- Two sustainability Interns started work in the department.
- Completed the response to GA Environmental Protection Division's questions about scope for the Nancy Creek restoration at Windsor Meadows Park project – 319 Grant.
