- Units responded to the 1000 block of Mount Vernon Highway for a reported outside fire. Upon arrival, crew observed a small fire in the front yard of a single-family residence. Personnel deployed two water extinguishers and one 1.75" hand line to extinguish the fire. Crew extinguished all hot spots during clean up. The burned area was in a natural wooded area on the front corner of the property. Further investigation found a ground light on fire with burned wires. Crew found one other light to have fire damage to the wires, but not on fire. Crewmembers attempted to locate a shut off for the lights and found an electrical box on the exterior of the house that was making a humming sound and was warm to the touch. Personnel shut of the power switch to the box and the humming stopped.

FIRE TRAINING

- Five new employees completed the two-week Fast Track program for their employment, which ended in a day of live fire training at DeKalb County as well as being sworn in by Chief Sanders. They have now received their station and shift assignments.

INSPECTIONS

- There were 116 inspections conducted with 40 violations cited.

SAFETY EDUCATION & PUBLIC RELATIONS EVENTS

- SSFD oversaw seven community events with 603 participants: four fire drill assessments, two Community CPR training, and one Senior Fire & Fall prevention class.
