• Issued 8 traffic citations, conducted 4 field interviews and continued to check City parks on bicycles.

• Reported 175.25 work hours composed of 20 shifts this past week. Additionally, the Unit conducted 1 house checks, 164 business checks, and issued 29 handicap-parking citations.

OPERATIONS

- Responded to 325 calls: 2 Fires, 116 EMS, 25 Service, 144 Good Intent, 34 False Alarms
- Units responded to reports of a cooking fire in the 2400 block of Sandalwood Drive. Crew arrived on scene to a three-story apartment building with nothing showing. Personnel entered the apartment and found an ABC extinguisher had extinguished the fire prior to arrival. Crewmembers removed a pot of oil found sitting on the floor. The pot had burned a spot in the floor from being hot. No hazards on scene. Personnel advised the resident and maintenance that they would be able to re-enter the apartment after crew cleaned the extinguishing agent.
- Units responded to a technical rescue call in the 200 block of Azalea Drive. Crew arrived on scene to a
 flatbed trailer loaded with a bobcat down a steep embankment with the driver inside of the bobcat.
 Personnel secured the bobcat and trailer using chains and ratchet straps to large trees on the property. Once
 the trailer and bobcat were secured, the driver was able to remove the door to the bobcat using the
 emergency handle. Crewmembers assisted the driver from the bobcat and denied any medical complaints.
