- Hammond Park erosion project: The final walk-thru was held this week with the designer and contractor. A short
  punch list of tasks was generated. The contractor should have these completed within days. The project will
  conclude and project considered accepted thereafter.
- Overlook Park Streambank Restoration project: The National Parks Service is in possession of the City's permit request for construction. This is a 30-day permit review period. A contractor working through pre-negotiated state contract pricing has been selected for this work.
- Bids opened for the Sandy Springs Middle School intergovernmental improvements project on 12/16. The scope of work is for the resurfacing and painting of two outdoor basketball courts and adjacent stormwater system upgrades to guarantee ponding on the court no longer occurs. Staff had a discussion with the principal on budget status and the impact of the 12/16 bid response on remaining project element choices.
- Staff met with the Hammond Park turf field provider to review best practices for maintenance on the field by others needing to use lifts and trucks to access field lighting, for fence repair, etc.
