




# SIGNIFICANT EVENT



• Overlook Park dock handrail set was installed beyond the end of the gangway to the dock. The handrail addition was added to three new dock sections that are being used to couple the gangway and the dock. The handrail addition protects the public from a fall into the water where the walking surface is more narrow. A ladder was installed at the dock as well. The ladder will be used by paddle boarders and kayakers to exit the water if they are unable to climb from their craft to the dock. The ladder also provides a level of security should a person enter the water unprepared and need to get back on the dock.



# Maintenance/Landscaping

- Staff met with an irrigation specialist at Greenway North to diagnose irrigation problems. There are wiring issues, and several irrigation decoders are no longer working. The decoders used in the original install are now obsolete.
