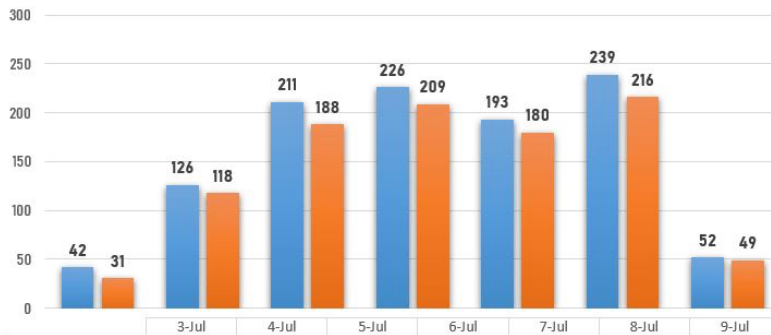

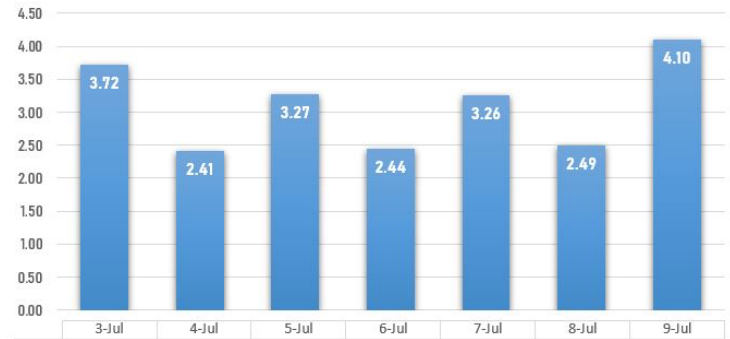

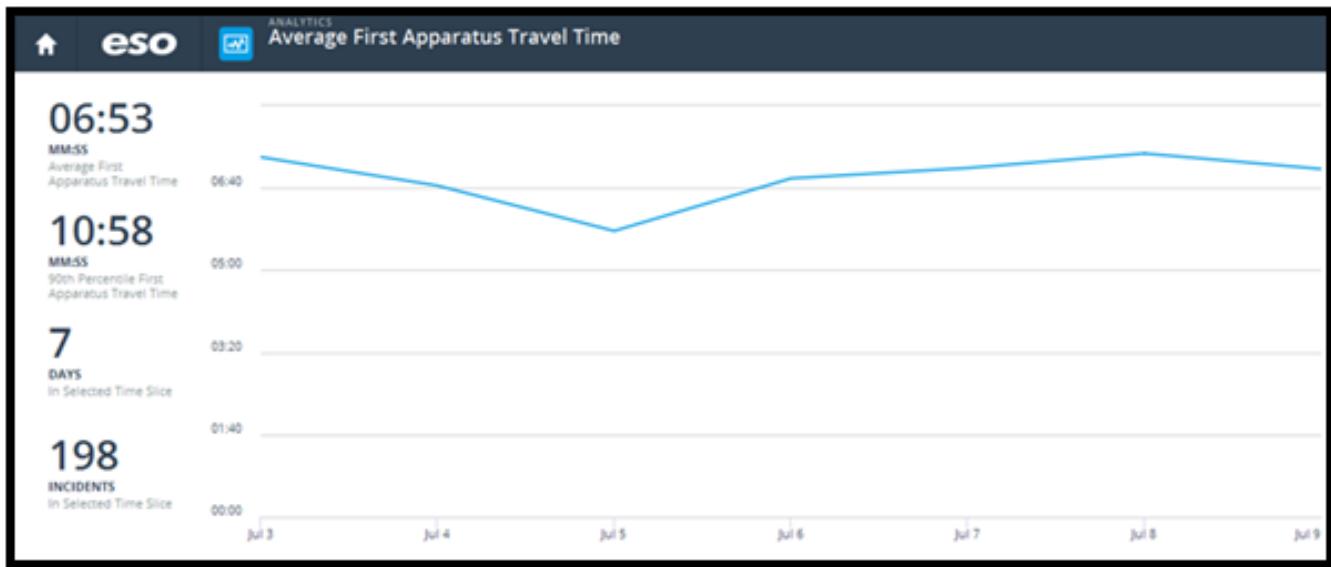
CITIZENS ON PATROL UNIT

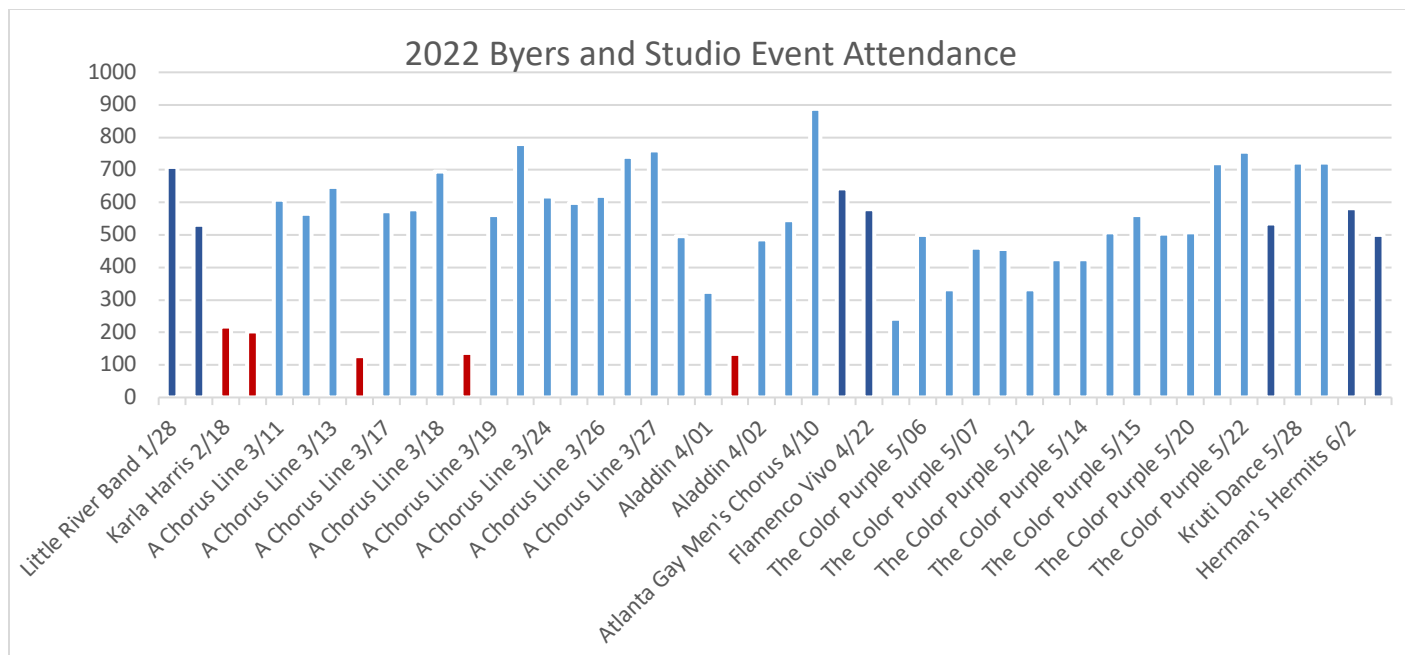
