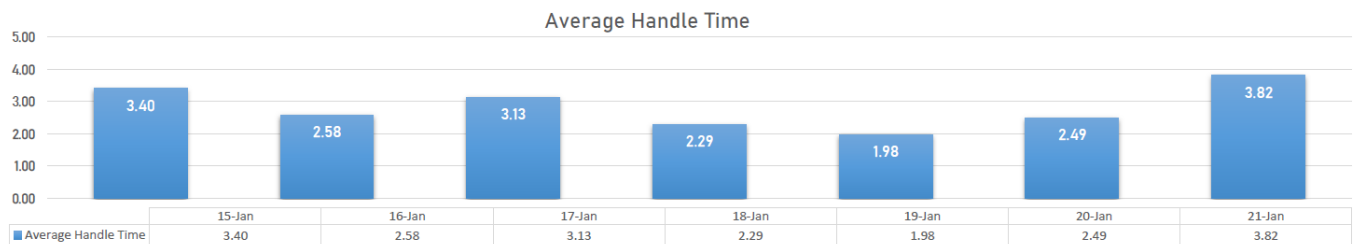

SIGNIFICANT EVENT

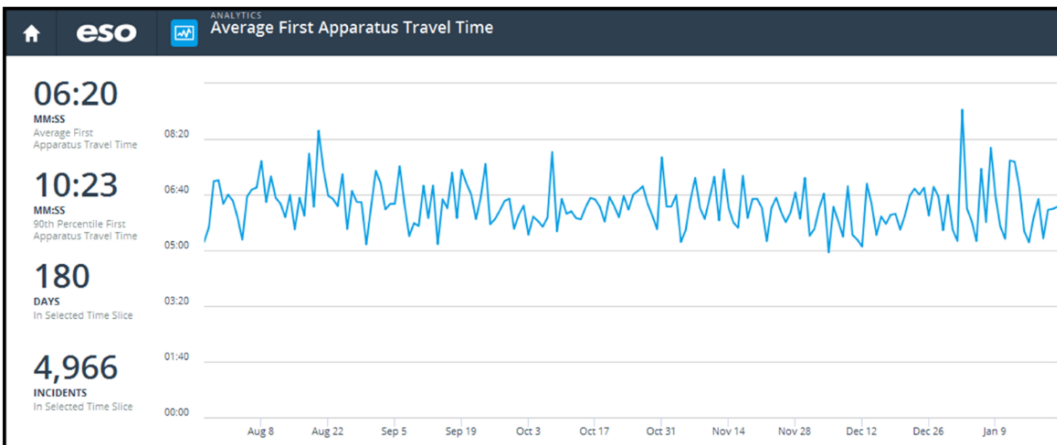
- Officers staged near Windsor Parkway to conduct surveillance due to a Flock notification that an Entering Auto suspect’s vehicle was in Atlanta. Upon the vehicle entering Sandy Springs (Flock notification), Officers conducted a traffic stop. The investigation revealed an odor of marijuana, and that the driver was driving on the roadway with a suspended license. Further investigation revealed a bag of marijuana, tools commonly utilized for entering autos (window punches, gloves, face mask, flashlights), along with various credit cards, two handguns, cell phones, and two laptop computers.

The driver and passenger were transported to CID and interviewed by Detectives. Criminal warrants obtained for the Driver included Traffic offenses (2), Possession of Marijuana less than an ounce, Loitering and Prowling, Possession of tools for the commission of crime, and Possession of firearms by convicted felons and first offender probationers. Criminal warrants obtained for the Passenger included Possession of Marijuana less than an ounce, Loitering and Prowling, and Possession of tools for the commission of crime. As a result of the interviews, the offenders admitted to multiple entering autos in Sandy Springs. CID will be obtaining additional criminal warrants for at least six Entering Autos; Theft by Receiving for the handguns (in which it was admitted that they were stolen) and property once identified that was in their possession.

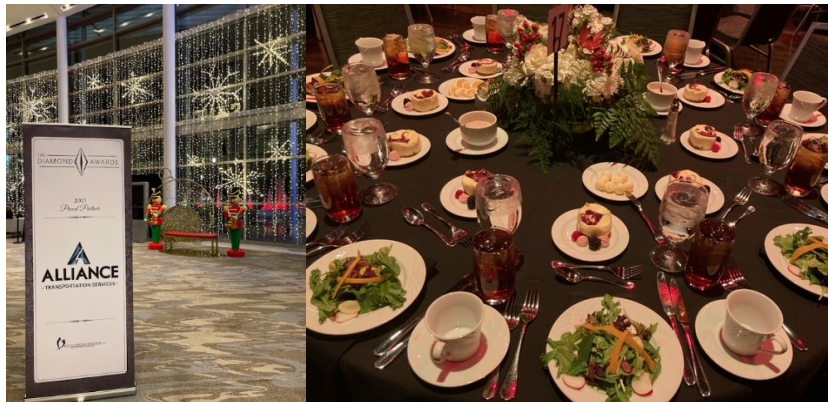

Projects

- Ison Springs Elementary - elements of the project are complete, including the installation of a small turf field, drainage and stormwater additions, soft walking track with fitness pieces, a pavilion, in-ground commercial umbrellas, security fencing, and tree and garden material installation.
- Ridgeview Charter Middle has two tennis and six pickleball courts at 95% completion. This project has been managed by Fulton Schools and partially funded by the City. Maintenance and scheduling will be a function for the City once opened to the public.
- Trail 2A - Grading and stone install commenced on Cimarron Parkway. Tree and bush removal further east on Cimarron. Silt fence installed. Conduit for lighting and cameras in progress. Pervious concrete test section poured. Spur trail at 90%.
- Trail 2A Two week lookahead - with drier conditions, grading for trail on Cimarron Parkway will resume. Resumption of pervious concrete sections planned near the creek on Cimarron Parkway. Trenching for power and camera conduit continues.

Maintenance/Landscaping

- Staff had three trees removed along the front of Windsor Park that were considered to be hazardous from limbs that were constantly falling onto Windsor Parkway. Upon inspection, two were hollow inside meriting the need for removal. The third tree was losing footing into Nancy Creek and at risk of toppling.
- Staff had landscape contractor clean up the corner island at Abernathy and Roswell Road. The contractor removed bricks, trash, and unsightly plant material from the area, and a load of organic compost was thoroughly tilled in to enrich the soil for springtime planting. After conditioning the soil, the area was covered in brown shredded mulch.
- Staff assembled new Teeter Totter at Overlook Park.
- Custodial deep cleaned gymnastics mats, glass windows, and all hard surfaces at Hammond Park building.
- Staff repaired stone retaining wall at Marsh Creek Rain Garden where some of the stones were loose.
