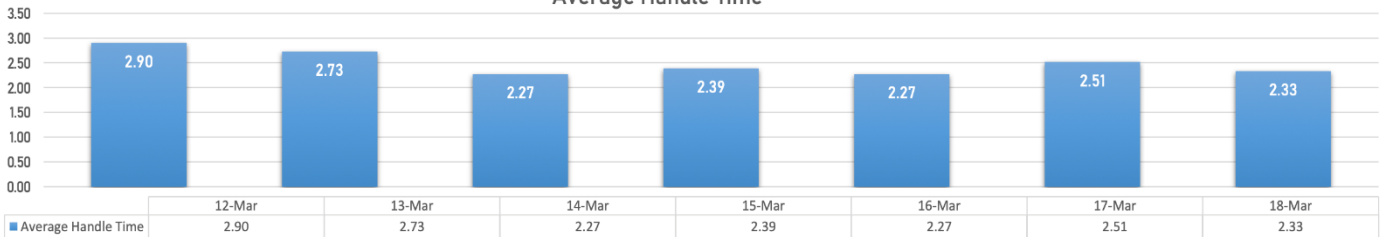

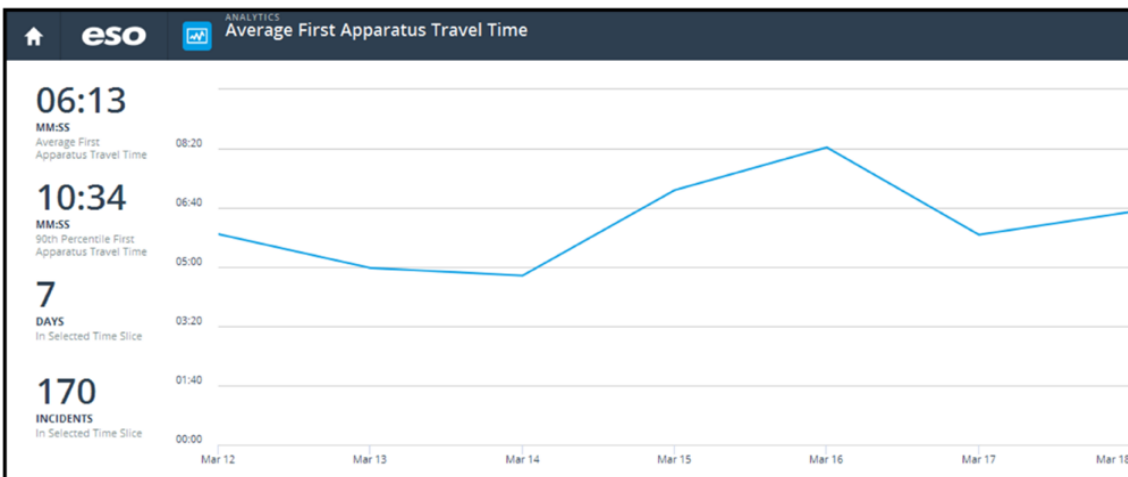
**SIGNIFICANT EVENTS**

- **Officer Struck by Vehicle Spalding Drive at Dalrymple Road – 03/14/2023** - Officers were on location of a traffic stop/DUI investigation when a passing motorist struck a Traffic Officer. The Traffic Officer sustained several injuries and was immediately tended to by another officer on scene. The injured Traffic Officer was transported to North Fulton Hospital. SSPD Traffic Unit responded and investigated the accident.
- **Swatting Call - 03/16/2023** - A call was placed to the Dunwoody Police non-emergency line. The caller advised he killed his father and was holding the mother hostage. After several knocks on the front door with see-through glass, a male subject was observed walking towards the front door. Verbal commands were given, and the male opened the front door. He was immediately detained. No one else was inside the home. It was determined that the twenty-one-year-old male with autism lived at the home and his parents were on vacation in Florida. Contact was made with the mother, and she was informed of what had occurred. The male advised he suspected a swatting call was coming to his home after stating he had online contact with individuals who play this prank. CID was on scene and will follow up with the investigation to try and determine the source of the swatting call.
- **Swatting Call, 03/19/2023.** ChatComm received a phone call and the caller stated he was a 16-year-old male and had just shot his father in the head with a revolver. SSPD units arrived on scene, made contact with the residents, and everything was fine. ChatComm advised the call came to the ChatComm administrative line from a company in Ontario, Canada. Prior to receiving the hoax call, ChatComm received a FBI memo concerning an individual making hoax calls to different agencies threatening to shoot family members and law enforcement officers.

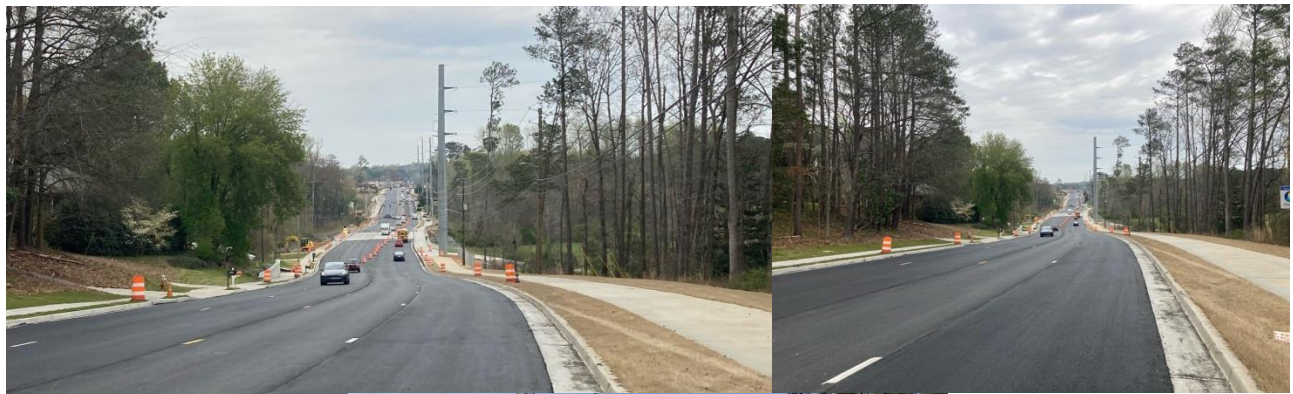

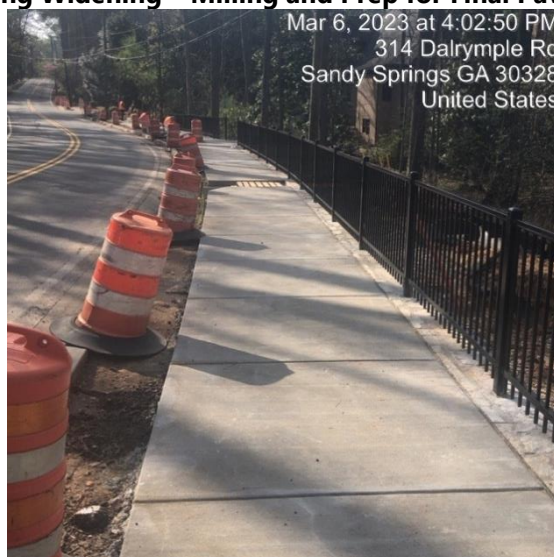
