


SIGNIFICANT EVENTS



Maintenance/Landscaping

The azaleas will thrive in the shade and provide showy, bubblegum-pink blooms each spring.

The front of the school had problems with soil washing onto the sidewalk every time it rained, so azaleas and mulch were added to correct the issue.
