



SIGNIFICANT INCIDENTS

assistance, the victim was pulled back to the riverbank. AMR handled patient care.

- A reported structure fire in the 4100 block of The Valley. Upon arrival, personnel observed smoke coming from the bottom level of a three-story multi-family structure. Personnel found a small fire in the bathroom and moderate fire in the walls and ceiling between the first and second floor units. The fire was extinguished, and overhaul was completed. The Fire Marshal's Office was contacted for an investigation.
- A reported arcing fire in the 5100 block of Roswell Road. Upon arrival, personnel found light smoke conditions at a multi-family structure. Personnel found heat coming from the top electrical socket outlet utilized by a kitchen appliance. Power to the outlet was secured. No fire was detected.
