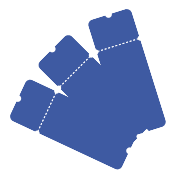

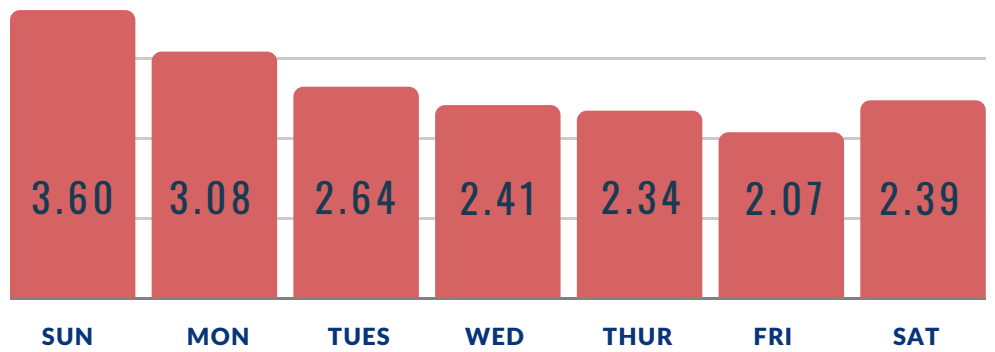

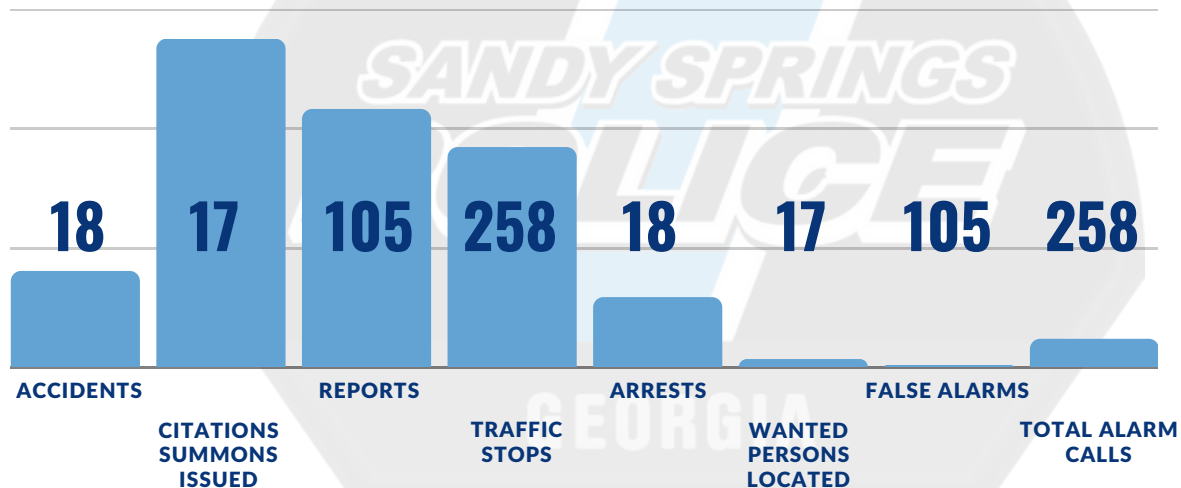

CITIZEN'S POLICE ACADEMY

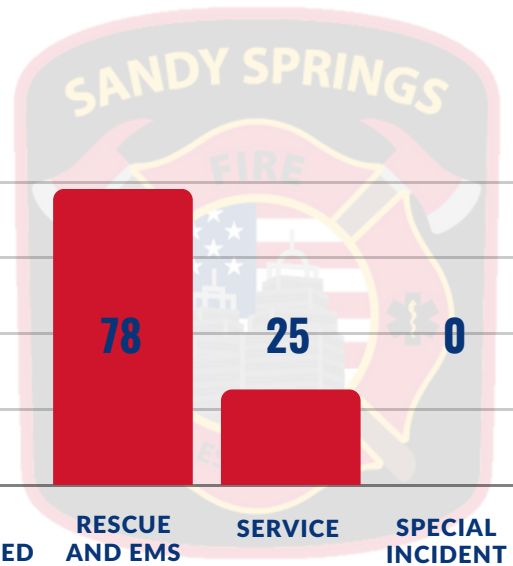

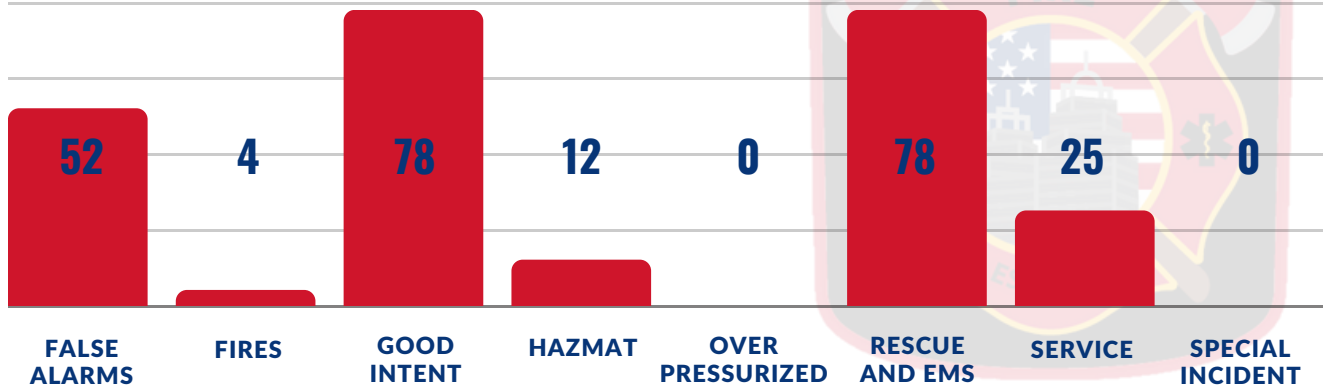

SIGNIFICANT INCIDENTS

Fire units responded to the following reported incidents:

- A structure fire in the 500 block of Winfield Glen Court. Personnel found a working fire at a single-family structure in the garage and above room. The fire was extinguished, and ventilation was performed. The Fire Marshal's Office was contacted for an investigation.
- A gas leak in the 6400 block of Roswell Road. Personnel were advised of two leaking 50lb propane tanks in the back of a truck. The temperature within the tanks had risen causing off-gassing through the pressure valves. The driver was advised to allow off-gassing in a safe location away from any ignition source. There were no immediate hazards.
- An odor of smoke in the 7000 block of Spalding Forest Court. Personnel observed an odor of smoke and an audible alarm at a three-story multi-family structure. Upon entry to the unit, personnel found moderate smoke from burnt food on the stove. Power to the stove was secured and ventilation was performed.
- A gasoline spill in the 5300 block of Peachtree Dunwoody Road. Upon arrival, personnel were advised that a car inadvertently hit the water heater in the garage. The gas supply to the water heater was bent and leaking. Power to the gas was secured and all breakers were shut off. Ventilation was performed until gas readings were at zero.
- A structure collapse in the 2700 block of The Valley. Personnel arrived at a three-story multi-family dwelling and was advised by resident that the ceiling collapsed in a bedroom. A drywall collapse from ceiling was found with no damage to the roof or structural members. There were no injuries, and no further hazards were found. Property maintenance was notified.
- A motor vehicle accident in the 7300 block of Roswell Road. Upon arrival, personnel found a vehicle that had been hit by a tree. The tree limb broke through the windshield and impaled the passenger. Personnel assisted AMR with removing the patient from the vehicle and into the ambulance. Patient care was handled by AMR.

MAINTENANCE/LANDSCAPING

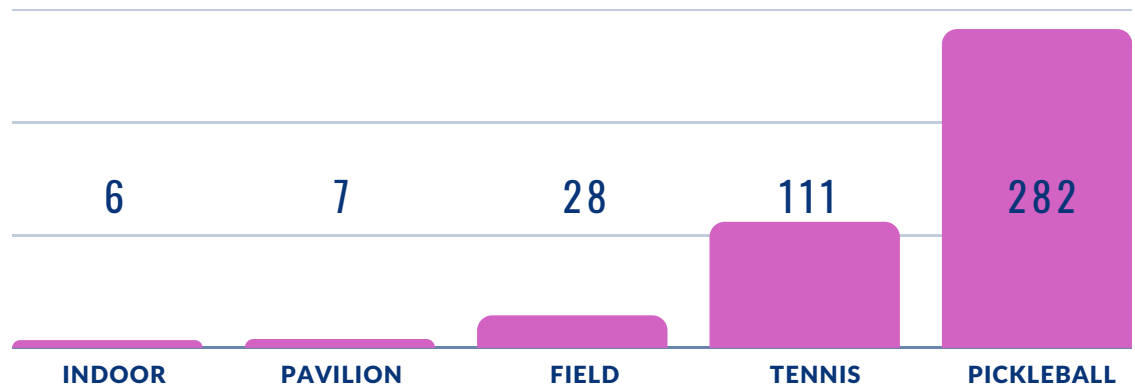

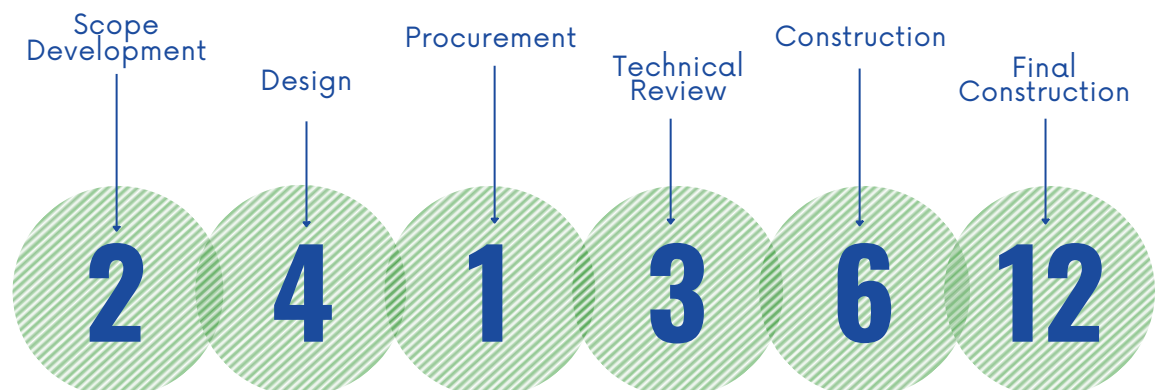
