

SIGNIFICANT EVENTS

Subject was transported to North Fulton hospital where his injuries were determined to be non-life-threatening.

 while they were leaving the apartment complex in their vehicle, a black suburban pulled in front of their car,
 attempting to prevent the victim from exiting the complex. The victim drove around the suspect once they
 motioned for the victim to roll down their window. The suspect began to follow him on GA 400 north, when the
 victim heard a loud pop followed by another loud pop and heard something hit his vehicle. The victim's vehicle
 had been hit by the gun fire.

- Staff repaired irrigation lines at Overlook Park.
- Staff cleaned gutters at Morgan Falls Athletic Complex concession stand.

- Contractor Atlanta Sport and Social Club providing adult flag football at Hammond Park and adult soccer and kickball at Dunwoody Springs Elementary.


