





SIGNIFICANT INCIDENTS

Fire units responded to the following incidents:

- A reported structure fire in the 8800 block of Dunwoody Place. Personnel found heavy fire through the roof of a multi-family residential structure. Two firefighters were briefly trapped due to the breezeway collapse. Twenty units were affected. Red Cross assisted displaced families. The Fire Marshal's Office was on scene for investigation.
- A reported motor vehicle accident at I-285 westbound and Roswell Road on ramp. Personnel found two
 vehicles involved in an accident with no entrapments. All occupants were safely extricated from the vehicle
 prior to arrival, four patients were transported to the hospital.
- A reported motor vehicle accident in the 8400 block of Roswell Road. Personnel found four vehicles involved in an accident with no entrapment. AMR handled patient care.
- A reported gas leak in the 5400 block of Roswell Road. Personnel arrived at a multi-family structure and was advised by residents of an odor of gas. Elevated gas readings were found in two units. Atlanta Gas was notified and power to the gas was secured. Ventilation was performed.
- A reported structure collapse in the 8300 block of Grogans Ferry Road. Personnel found a truck that hit the corner of a house and bent the gutter. There was no structural damage to the home.
- A reported gas leak in the 6800 block Glenlake Parkway. Personnel arrived at a two-story apartment building and was advised by resident of an odor of gas. Upon entering units, elevated gas readings were found. Atlanta Gas was notified and power to the gas was secured. Ventilation was performed.
- A reported motor vehicle/pedestrian accident at I-285 eastbound and Lake Forrest Drive. Personnel found a single vehicle accident and later observed a crash and an individual running through the blockade. AMR assisted with patient care.
