

SIGNIFICANT EVENTS

- Lt. David Roskind traveled to Israel to attend a week-long seminar hosted by the Secure Community Network (SCN) highlighting the challenges of global terrorism and combating Anti-Semitism. Executive and Command law enforcement personnel from metro Atlanta, Florida, Tennessee, and Alabama were invited to participate in the seminar, which included:
 - How to manage intelligence resources and analytics to determine where to place and use assets to respond to an act of terrorism.
 - Methods to combat acts of Anti-Semitism.
 - Understanding the Jewish population makes up approximately 2% of the population but Anti-Semitism has significantly increased due to various factors and actions on how to combat the Anti-Semitism.
 - Ensure law enforcement is engaging and consistently developing a relationship with the Jewish community versus just responding to the community when an incident occurs.


SPECIAL OPERATIONS HIGHLIGHTS

- Traffic stop Disorderly Conduct Drug arrest 7.9 grams marijuana seized.
- Speed enforcement detail on GA 400/Hammond which resulted in 10 stops and 11 citations.
- Felony Arrest Possession of Firearm by convicted Felon.
- Worked Highpoint/Northland stop sign complaint which resulted in 2 stops and 2 citations
- A lawful vehicle search was conducted during a traffic stop. 3.3 grams of marijuana was seized from the center console of the vehicle.
- Assisted Traffic Unit on a traffic stop. K9 Brutus deployed on an open air controlled substance sniff on the exterior of the vehicle. After a positive K9 alert, a lawful vehicle search was conducted. Inside the vehicle, found prior evidence of narcotics, 1 Glock handgun, and \$7,564.00 USD. Through further investigation, it was learned that the driver was a convicted felon.
- Assisted Federal Agency with (10) K9 sniffs at 3 different storage units in Gwinnett County. The Federal Agency opened the units and seized a large amount of charcoal infused methamphetamine. (Rough estimate - 42,000 kilos or 92,400 pounds).

VOLUNTEER UNIT

The VIPS and Citizens on Patrol (COP) units reported 138.25 total volunteer hours . The COPS hours composed of 9 patrol shifts this past week. Additionally, the COP unit conducted 31 house checks, 81 business checks, issued 13 handicap-parking citations, assisted with one special event, and assisted officers on 8 traffic related incidents.
