

NORTH DISTRICT

- Reported 3 entering auto incidents
 - 1 vehicle entry with forced entry.
 - 1 unsecured vehicle was entered. An arrest was made and property recovered.
- Reported 1 armed robbery incident
 - Two unknown, armed individuals entered a business location. A worker for the location pulled out his handgun and the suspect began firing at the employee who returned fire. No one was injured. Approximately \$5,000 worth of t-shirts were stolen.
- Reported 2 aggravated assault incidents
 - 2 males were in a domestic violence fight. A third male got involved and shot the victim in the leg. He sustained a non-life threatening injury. Arrests were made.
 - Victim and offender got into a fight. The Offender stabbed the victim with a screwdriver. An arrest was made.

 1 vehicle was entered with forced entry
- Reported 1 armed robbery incident
- Reported 1 homicide with arrest made
 - A Hispanic male was in the parking lot with a gunshot wound to the leg and the abdomen. Officers rendered aid to the victim. The victim was transported to North Fulton Hospital where he died. CID responded to the location and took over the investigation. The offender turned himself in later that night and was arrested.

PATROL SIGNIFICANT EVENTS

- Units were dispatched to a threat made against Temple Sinai Synagogue. SSPD asked for assistance from surrounding agencies. It was determined to be a false threat. This is believed to be related to similar incidents across the country. The FBI is assisting in the investigation.
- A traffic stop was conducted on a vehicle speeding on Roswell Road. Upon making contact with the driver, the officer observed an odor of marijuana emanating from the vehicle. During a probable cause search of the vehicle, the officer located 39 grams of marijuana and 22 grams of psilocybin mushrooms. A passenger in the vehicle claimed ownership of the contraband and was placed under arrest. The offender was charged with Possession of Marijuana and Possession of Schedule I Drug – both felonies.

VOLUNTEER UNIT

The VIPS and Citizens on Patrol (COP) units reported 84 total volunteer hours. The COPS hours composed of 7 patrol shifts


this past week. Additionally, the COP unit conducted 18 house checks, 31 business checks, issued 4 handicap-parking citations and assisted officers on 4 traffic related incidents.

SIGNIFICANT EVENTS

• On 09/08/2023, 8895 Carroll Manor Drive - investigation and evidence revealed an illegal marijuana transaction had taken place, which turned into an armed robbery. Shots were fired, resulting in one of the residents of 8895 Carroll Manor Drive sustaining a gunshot wound to their arm and abdomen and another person involved in the robbery sustaining a gunshot wound to the torso. They fled the scene with a large amount of marijuana. On 09/09/2023, the deceased body was found off Cascade Road in the City of South Fulton. It is believed that while fleeing, the injured suspect died of his injuries. The City of South Fulton Police and the Sandy Springs Police worked in tandem with the investigation. Probable cause was developed, and all parties involved have been arrested and charged with felony murder. The investigation is still pending, and additional charges may be forthcoming.
