



#### PATROL SIGNIFICANT EVENT

- On 11/18/2023 at 9:45am, SSPD officers responded to Congregation Or Hadash at 7460 Trowbridge Road in reference to a bomb threat. After a thorough check of the area by law enforcement officers, nothing unusual was located and the services continued as normal.
- On 11/22/2023 at 7:15pm, a SSPD officer responded to a person locked inside the bathroom at Lost Corners Park (after the park was closed). Once contact was made, the suspect came out of bathroom and immediately admitted they had a "gram of weed" on them. The SSPD officer went to put suspect into custody and the suspect began to resist and fight. The SSPD officer was able to subdue subject by taking them to the ground and then into custody. The suspect was charged with felony obstruction, possession of marijuana, and criminal trespass.

The boardwalk contractor continues to make progress as they will soon be moving from the lake to land as the boardwalk proceeds east towards the Edgewater Apartments clubhouse.




- Staff participated in a regional workgroup discussion on best urban forestry practices, 11/14/2023.
