


- SCU assisted Patrol with responding to several crimes in progress calls.







MORGAN FALLS ATHLETIC COMPLEX IMPROVEMENTS

• Safety netting pole installation work continues. Cabling for netting is being installed as well.

SPRINGWAY TRAIL 2A (PHOTOS)

- At the December 19 Mayor and Council Meeting, a change order for additional work was approved. The bulk of the cost for added work relates to delays encountered at Orkin Lake where a boardwalk is being installed. Resistant rock and unknown conditions impacted delays as piers were installed to the lake bottom. Projections for project completion are now in the month of August, 2024. The rough boardwalk is presently at 1,350 feet in length.
- At the river park-Georgia Power section 142' of trail and curb was installed this week. Adjacent sloped hillside stabilized with grass matting. A driveway entrance to the Georgia Power substation at Morgan Falls dam is being readied. Work on the boardwalk while lake levels are being drawn down through use of a generator and pipe system continue.





PROJECTS

- Springway Trail 2A Two Week Lookahead
 - Dec 26 Dec 29 Pouring header curb at the river park. Pour driveway at Georgia Power's lower ranch building on Morgan Falls Road; contingent upon Atlanta Water's ability to stop sizeable leak on the upper driveway outside of the trail project area. Boardwalk work and generator use continues.
 - Jan 1 Jan 5, 2024 Setting the prefabricated, 85' metal bridge by crane at Monterey Parkway. This connection over the creek at the tennis courts of Edgewater Apartments will lead future trail users to a short connection that will connect with the near completed Cimmaron Parkway length of trail.

MAINTENANCE/LANDSCAPING



- Unclogged sewage pipe between the bathrooms and lift station at Overlook Park after sewage backed up and began coming out of floor drains and commodes were overflowing.
- Scheduled the wheelchair We-Go-Swing for installation next week for the Overlook Park playground.

There was enough space for guests to lie down with blankets and pillows to get comfy during the movie. Frozen character actors did a meet and greet, posed for photos, and interacted with guests. Guests enjoyed the expanded sensory table, filled with magic snow, robotic Olaf, sensory pad, lava timers, and more assorted tactile items. Staff served hot cocoa, and a variety of snacks, and everyone received a goody bag.
