

Generators used to pump Orkin Lake levels down are un use. Use of a siphon system to maintain lake levels once down to a depth needed to make pier drilling operations more effective, is being evaluated and priced. The boardwalk has traveled 1,370'.

The boardwalk subcontractor returns for the advancement of pier drilling and structural work associated with the boardwalk. Continuing lowering Orkin Lake if necessary.




