

• In-stream and major earth work at the creek and park completed. Development of a small, boulder lined outlook at crest of creek is in progress. Erosion control matting in-place in advance of weekend rain. Plantings to begin in the week of February 19.

MORGAN FALLS DOG PARK IMPROVEMENTS

On-site public input to address a variety of potential future, improvements at the dog park areas is scheduled Saturday, February 10 from 2-4 pm and Sunday, February 18 from 1:30 - 3:30 pm. The February 10 date may require cancellation and rescheduling due to a significant rain forecast. Communications will announce a new date on various platforms if this becomes necessary.

PROJECTS

SPRINGWAY TRAIL 2A

- Additional rip rap stone was laid into creek slopes at the Monterey Parkway bridge area. The trail from Cimarron Parkway through the bridge section and onto the Edgewater Apartments clubhouse lot is completed excepting a small section awaiting a light pole removal. Additional light grading and cleanup through this area continue.
- Georgia Power is on scene coring for a new pole for a third day. Concrete abutment work for the boardwalk as it arrives at Monterrey Parkway (in future) is in progress. The boardwalk is at 1,400' from its origins at the Orkin lake spillway. Round the clock pumping down of the lake level has achieved a 7' drop from the spillway. Geotechnical personnel will visit the east end of Orkin Lake this week to evaluate conditions and auger for rock depth and hardness if conditions are sufficiently dry. Lake level will be low enough late Wednesday to have fully exposed lake bottom from the terminus of the boardwalk where pier drilling continues to the location where plans have the boardwalk exiting the lake near the clubhouse.
- Springway Trail 2A Two-Week Lookahead
 - February 5 9 New fence installation in the Georgia Power section this week. The contractor's storage lot on the south end of the dog park will be relocated. New trail construction at the southern end of the dog park will commence. Boardwalk work continues, lake level reduction resumes (after prior weekend and Monday's forecast for rain.)
 - February 19 23 Complete trail construction at the former storage yard location at the river park. Boardwalk work and lake lowering 9if necessary) continues.

MAINTENANCE/LANDSCAPING


- Staff produced a design to correct the drainage and erosion issues along the tennis courts at Hammond Park. The scope of the project will include a concrete curb and gutter. The procurement process has begun and bids are due March 4th.
- The landscape contractor has begun winter pruning at all parks, to include ornamental grasses, liriope and hydrangea.
- Staff built and installed two new planter beds at Lost Corner community garden to replace two old, rotted beds.

- Birds Georgia (formally known as Georgia Audubon) led bird walk at Morgan Falls Overlook Park with 11 participants.
- Jeremy Rogers, Paint like Bob Ross contractor, led an advanced Paint like Bob Ross class with six participants. To enroll in this class students needed to have attended at least six Paint Like Bob Ross Foundational classes or have been invited personally by the instructor.
- Staff hosted the 14th annual Daddy Daughter Dance. This event sold out early with 223 presales and a waitlist. There were 207 guests in attendance at the Studio Theater. The Recreation Department provided DJ, photo booth, candid photography, prizes, catering, and goody bags. New this year, staff offered an eco-friendly dining experience. All disposal items were recyclable or compostable. There were recyclable aluminum cups, bamboo plates, and cutlery that were compostable.
- The Photography Club had 11 participants and discussed photographs that are emotionally impactful at Lost Corner Cottage this week.
- Staff held a pre-track season meeting at Hammond Park with 30 parents to discuss the upcoming season.
- GRPA Basketball league played four games through the Cobb County Youth League. The 12 U boys won, 10 U boys won 1 and lost 1 game, and 12 U girls lost their one game.
- After-school youth basketball 2nd and 3rd grades as well as 4th and 5th grade teams played eight games at Spalding Drive Elementary this week.


