



# SIGNIFICANT EVENTS

Fire units responded to the following reported incidents:

- A structure fire at a two-story townhome with no visible smoke or fire showing from the exterior in the 500 block of Northridge Drive. Personnel were advised of a bathroom ventilation fan that had burned. The fire appeared to have melted the water line supplying the toilet, which effectively extinguished the fire. No fire extension or smoke damage was found. Power to the ventilation fan was secured.
- A gas leak in the 8400 block of Valemont Drive. Personnel observed that the residential gas line had been cut. Atlanta Gas Light was notified and was able to secure the leak.
- A cooking fire at a four-story multi-family structure with no visible smoke or fire showing from the exterior in the 6500 block of Roswell Road. Personnel were advised of food that was inadvertently left on a stove and found light smoke in the breezeway and unit. The fire was extinguished prior to arrival. No fire extension was found. Ventilation was performed.
- A single-car vehicle accident with multiple injuries at I-285 westbound and Northside Drive off-ramp. Personnel assisted with triage and patient care. AMR assisted with patient care and transport.
- A structure fire at a two-story commercial structure with smoke and flames showing from the exterior in the 8900 block of Roswell Road. The fire was extinguished, and ventilation was performed.

- A gas leak in the 6500 block of Aria Village Drive. Personnel observed an odor of gas in the hallway on the first floor with gas monitor readings at elevated levels in the hallway and inside a unit on the first floor. Personnel found a gas stove burner left in the on position but was not lit. Power to the burner was secured and ventilation was performed.
- An arcing fire at a three-story multi-family structure in the 100 block of Summer Drive. Personnel were advised of flames found behind a utility closet door and found burnt electrical components for the water heater. SSPD was on scene and assisted with evacuation. The fire was extinguished by SSPD prior to arrival. Personnel secured power to the water heater and performed ventilation.



As part of our Mount Vernon Highway/Johnson Ferry Road Improvement Project, Johnson Ferry Road AND Mount Vernon Highway, from Roswell Road to Boylston Drive, will be brought down to ONE LANE, starting Wednesday, March 13, 2024, as the inside lanes of each road will be closed through late August.

As part of this traffic shift, the current left-through lane on eastbound Mt. Vernon Highway between Roswell Road and Galambos Way will become a left-turn ONLY lane. The right-through lane on Johnson Ferry Road will become a right-turn, left-turn, and through lane. Expect traffic delays during your morning and evening commutes.

Our Traffic Management Center (TMC) will be closely monitoring the traffic signals, and adjust the timing as necessary to help keep traffic moving.


# **SPRINGWAY TRAIL 2A**


