





As part of our Mount Vernon Highway/Johnson Ferry Road Improvement Project, Johnson Ferry Road AND Mount Vernon Highway, from Roswell Road to Boylston Drive, is down to ONE LANE, as the inside lanes of each road will be closed through late August.

As part of this traffic shift, the current left-through lane on eastbound Mt. Vernon Highway between Roswell Road and Galambos Way will become a left-turn ONLY lane. The right-through lane on Johnson Ferry Road will become a right-turn, left-turn, and through lane. Expect traffic delays during your morning and evening commutes.

Our Traffic Management Center (TMC) will be closely monitoring the traffic signals, and adjust the timing as necessary to help keep traffic moving.

# SUSTAINABILITY

- The Urban Forestry Program was able to meet with local stakeholders at the Sandy Springs Library to mark suitable planting sites for 10 Eastern Hemlocks and 2 native Dogwood trees. Through community collaboration and input, staff was able to hand excavate the rootball for all 12 trees and transplant them within the existing Reading Garden at the library. These trees will be maintained and monitored for the next 2-3 years to ensure health and recovery from the transplanting process.
- Staff is seeking to implement a new Best Management Practices (BMP) program at Big Trees that will run through 2030.
- Staff launched the Sandy Springs Eco-Steward Program. The Eco-Steward program has reached sign-up capacity and the first session's classes will continue through July. Registration for future sessions is currently open for local residents eager to engage meaningfully with our many greenspaces and distinctive urban forest.
