SPRINGWAY TRAIL 2A

- Piers and framing work at the boardwalk is now at 2,647' from the lake spillway leaving 284' to make connection to Monterey Parkway. In the closing days of the previous week, rain and less than ideal drilling conditions slowed work to 11.8' per day from what has become a 20' per day average in the last several weeks. The boardwalk contractor is off this week.


