





SPECIAL OPERATIONS HIGHLIGHTS

- SCU conducted 20 traffic stops with 2 citations issued.

- SCU assisted other SSPD units and other law enforcement agencies with investigating criminal activities.
- Traffic Unit conducted 146 traffic stops with 218 citations issued.
- Traffic Unit had 2 arrests for driving while unlicensed, 3 arrests for no insurance, 1 arrest for reckless driving, and 1 arrest for DUI.
- Traffic Unit conducted a hands-free while driving detail with 21 citations issued.
- K-9 Unit conducted 29 traffic stops with 31 citations issued.
- K-9 Unit had 1 arrest for driving while unlicensed.

VOLUNTEER UNIT

The VIP and COP units reported 235 total volunteer hours, which include 42 hours volunteered during the National Night Out event. Additionally, the COP units conducted 11 house checks, 64 business checks, issued 16 handicap parking citations, and assisted officers on 8 traffic related incidents.

SIGNIFICANT INCIDENTS

Fire units responded to the following reported incidents:

- A structure fire at a 3-story multifamily building with no signs of smoke or fire showing from the exterior in the 400 block of Morgan Falls Road. Upon entering the apartment, personnel encountered medium smoke conditions. The HVAC was confirmed as the source of the smoke and the unit was ventilated.
- A small outside fire in the 3900 block of Roswell Road. Personnel found a small area burning and successfully extinguished the fire.
- A outside brush fire in a green space by the 3900 block of The Valley. An area approximately 50'x20' was found to be involved. The contents were leaves, underbrush, and previously cut logs. Personnel cut a 4' chain link fence to access the fire. Personnel used approximately 2,000 gallons of water as well as fire rakes to extinguish the fire. Extinguishment was confirmed with a thermal imaging camera (TIC) prior to leaving the scene.






