SANDY SPRINGS PUBLIC SAFETY

SIGNIFICANT INCIDENTS-FIRE DEPARTMENT

Fire units responded to the following reported incidents:

- A weakened structure in the 1000 block of Preston Woods Trail. A vehicle lightly struck the corner of a multi-family building. No injuries or hazards were found, and the scene was left with law enforcement.
- A cooking fire in the 1000 block of Morgan Falls Road. Light smoke was found in an apartment breezeway, and the fire was already extinguished on arrival. The unit was ventilated and all units returned to service.
- A heavy equipment fire in the 1000 block of Whitemere Court. A box truck was found fully involved in fire and was extinguished with no injuries. The cause was traced to equipment in the truck.
- A transport vehicle fire on I-285 westbound. A flatbed truck carrying machinery was found with a trailer axle fire. The fire was extinguished with assistance from police and road crews. No damage to the equipment was reported.
- A building fire in the 6000 block of Roswell Road. Smoke was found in two apartment units and traced to a smoldering dryer vent pipe. The fire was extinguished with no further hazards.
- A trench rescue at Embassy Row. A worker was found injured inside a collapsed trench and was safely extricated using a crane and rescue equipment. The patient was transferred to EMS for care.
- A chemical spill on I-285. A liquid chlorine leak from a trailer was found to be mitigated by a hazmat contractor on scene. No further action was needed by fire crews. The scene was turned over to contractors and law enforcement.
- A unusual odor in the 5000 block of Roswell Road. An odor of gas was reported in a restaurant, but no hazards or gas readings were found. The building was cleared and units returned to service.
- A motor vehicle accident with injuries in the 6000 block of Roswell Road. A vehicle and tractor trailer were involved, but no injuries were reported. Vehicles were moved and the scene was left with police.
- A motor vehicle accident with entrapment on I-285. A passenger was pinned in a box truck after a collision with a tractor trailer. The patient was extricated and transferred to EMS for care.
- A machinery entrapment at a MARTA station. A person was found stuck beneath a catwalk but not struck by the train. The individual was extricated without injury and care was turned over to EMS.
- A motor vehicle accident with injuries on Galambos Way. An overturned SUV and a parked vehicle were found damaged. The driver was extricated and transferred to EMS. The scene was cleared by police.
- A building fire in the 1000 block of Northwood Drive. A bathroom fan fire had been extinguished before arrival. Personnel found smoldering materials and completed overhaul. No injuries reported.

POLICE DEPARTMENT - SIGNIFICANT EVENTS

- SSPD officers participated in Responding to Active Assailant refresher training.
- Officer J. Greene attended an engagement at the Courage Schools in Sandy Springs.
- SSPD officers attended engagements at the Holy Innocents' Episcopal School.
- SSPD Bike Unit coordinated a bike rodeo at The Goddard School of Sandy Springs.
- Officer J. Greene and Mrs. Jane Green, who is a SSPD VIPS member, provided a fraud awareness presentation at Atria North Point in Alpharetta.
- River Patrol had 311 contacts with individuals on the river. 10 individuals were not wearing a personal flotation device. 19 individuals were trespassing on private property to dive into the river.

POLICE DEPARTMENT - VOLUNTEER UNIT

• The VIP and COP units reported 305.5 total volunteer hours. The COP hours were composed of 16 patrol shifts patrolling a total of 774 miles. Additionally, the COP units conducted 29 house checks, 158 business checks, issued 26 handicap parking citations, handled 11 private property motor vehicle accidents, and assisted officers on 9 traffic related incidents.

CAPITAL IMPROVEMENT PROJECTS, TSPLOST, AND TRANSPORTATION

What's happening in Sandy Springs

Trenchless Stormwater Pipe Rehabilitation Project

In summer 2025, the Public Works Department initiated a multi-location stormwater infrastructure improvement project aimed at rehabilitating aging drainage pipes using cured-in-place pipe (CIPP) lining technology. This trenchless repair method reinforces existing pipes with minimal surface disruption, extending service life and ensuring compliance with current city standards. The project involved pipe rehabilitation at the following locations:

- 665 Glenairy Drive 403 linear feet of 24-inch diameter reinforced concrete pipe
- 335 Elden Drive 120 linear feet of 18-inch diameter pipe across three segments
- 6262 Ferry Drive 44 linear feet of 30-inch diameter pipe
- 7700 Colquitt Road 93 linear feet of 30-inch diameter pipe
- 175 Dalrymple Road 26 linear feet of 18-inch diameter pipe



Associated work required pipe cleaning and flushing, CCTV inspection and videography, liner installation, testing, and cure tracking as outlined in the approved plans and specifications. Construction activities commenced on May 28, 2025, and reached substantial completion on July 11, 2025.

City Council Meeting Recap

Consent Agenda

- Project S2193, Hammond Drive Widening: Council approved acquisition of Temporary Easement at 490 Hilderbrand Drive.
- Project S2193, Hammond Drive Widening: Council approved purchase of Temporary Easement at 491 Hilderbrand Drive and 500 Hilderbrand Drive.
- Project S2184, Spalding Drive Sidewalk: Council approved acquisition of Temporary Easement at 3245 Spalding Drive and 3285 Spalding Drive.
- Council accepted dedication of Right of Way as required by Development Regulation at 4575 Roswell Road.

Approval of a Project Framework Agreement with Georgia Department of Transportation for Project S2121–1, Roberts Drive Sidepath, Phase 1

Mayor and Council approved a Project Framework Agreement for \$216,000 in federal grants with a commitment of 20% in local matching funds for Engineering Services associated with the Roberts Drive Sidepath Project, Phase 1. The sidepath is planned for the south side of Roberts Drive from Dunwoody Place to Island Ford Parkway.

Approval of a Construction Contract Award to Tri Scapes for the 395 West Spalding Drive Stormwater Repair Project

Mayor and Council approved a \$1,106,985.77 construction contract award to Tri Scapes, LLC for a stormwater system repair project at 395 West Spalding Drive.

Approval of a Contract Award to Kimley-Horn and Associates for a Traffic Engineering Study of Riverside Drive

Mayor and Council approved award of a traffic engineering study in the amount of \$213,500.00 to Kimley-Horn and Associates to evaluate Riverside Drive from I-285 to River Valley Road.

Approval of a Construction Contract Award to NGT Group for Traffic Signal Upgrades on Roswell Road

Mayor and Council approved award of a \$298,034.75 construction contract to NGT Group to upgrade traffic signals on Roswell Road at the intersections of Northridge and Trowbridge. The work will also include upgrades to pedestrian facilities to include ADA-compliant features at both intersections.

Approval of a Contract Award to Modern Mobility Partners for a Transportation Master Plan Update

Mayor and Council approved award of a traffic engineering study in the amount of \$213,500.00 to Kimley-Horn and Associates to conduct a traffic engineering study of the Riverside Drive Corridor from I-285 to River Valley Road.

On Call Design Services Contracts

Council approved the new On Call Design Services Contracts at the August 5th City Council Meeting. These services are for the development of plans, specifications, and cost estimates for enhancements to City-owned properties. Seven pre-qualified vendors have been selected for contracts to include: The Collaborative Inc., Kaizen Collaborative Design Inc., Vanasse Hangen Brustin, Inc., Atkins Realis USA Inc., Root Design Studio, LLC, Starr Whitehouse Landscape Architects and Planners LLC, and Foresite Group, LLC.

RECREATION AND PARKS

Major Projects in Sandy Springs

Morgan Falls Dog Park Master Plan

Final approval for the concept plan is pending with Georgia Power. The proposed water line routing has been approved, and we have begun soliciting estimates from plumbing contractors. Staff are also in the process of negotiating the scope of design services.

Abernathy Greenway South Improvements

Staff are negotiating a financial commitment from Fulton County to relocate a 60+ year-old clay sanitary sewer line currently located in the stream bank. Coordination is ongoing with GDOT and the City to facilitate the property transfer needed to complete the greenway.

Morgan Falls Athletic Complex Phase III Improvements

It has been confirmed that the property affected by the planned stormwater improvements is owned by Fulton County; therefore, an easement will not be required. Staff are currently awaiting final approval from Fulton County to proceed with the installation of the new storm drain.

Hammond Park Master Planning

Preliminary concept planning is underway. The design team is incorporating feedback from the July 15, 2025 Concept Presentation into the overall project design.

Old Riverside Park Development

Staff has received a letter authorizing the extension of the existing concrete pipe culvert. Construction documents are 95% complete. Permit plans are under review by the Atlanta Regional Commission and MRPA. Water service permitting plans are also under review, and we have received comments from Fulton County regarding sewer service.

Maintenance/Landscaping Projects:

Fields one through five at Morgan Falls Athletic Complex were reconditioned this past week. The process started with scalping the turf and removing the thatch and any other loose material. Heavy core aeration followed to reduce compaction and allow the top-dressing leveling mix to integrate into the soil better. Products to rid and control weeds are applied along with root building fertilizer to jumpstart the growing process and encourage a quick green-up. The top-dressing mix, containing a mixture of seventy percent sand and thirty percent compost, was applied using golf-course ride on spreaders with leveling drag mats to ensure an even surface. The top dressing is put down at half inch rates until the soil surface is level. Some areas will have multiple inches applied due to heavy undulations, thus increasing down time of certain fields. The summer months are the best times to renovate turf grass due to vigorous growth and shorter down times.

Past Programming Highlights

- Birds GA led a bird walk and wildlife viewing with 25 participants at Overlook Park.
- Catalyst Sports, adaptive kayaking vendor, had seven adaptive athletes at Overlook Park dock.
- In partnership with Department of Natural Resources, Recreation Staff held adaptive fishing for 18 anglers at Morgan Falls River Park.
- Doc's Healing Hives hosted their first Bee Hive program with three Veterans and three Therapists. The program trains Veterans in the vocation of beekeeping at Crooked Creek Park.

Upcoming Programs and Events

- ATOK offers youth and adult Karate at Hammond Park Activity Building.
- Tai Chi classes are offered every Wednesday and Friday morning at 10am.
- Fit4Moms meet on Tuesdays and Thursdays at 9:30 am offering prenatal and postnatal workouts.
- <u>Kids' Yogaland hosts Young Yogi (age 6-9) on the City Green every Tuesday at 4:30 pm, Tween Yogi (ages 9-12) on the City Green every Tuesday at 5:30 pm, and Parent and Me Yoga (age 2-6) every Saturday at Morgan Falls Overlook Park at 10 am.</u>

SUSTAINABLE GROWTH AND ENVIRONMENTAL STEWARDSHIP

- July 18, 21, 22, 25: City Contractors conducted invasive removal at vacant FEMA lots and City properties.
- July 28: In coordination with Sandy Springs Conservancy, US bank volunteer event was held at Abernathy Greenway South. Eight volunteers spread mulch.
- July 30: Contractors removed dead trees and conducted tree pruning operations at Windsor Meadows.
- August 2: Contractors maintained 'Mayors Trees' on Roswell Road and Clifton. These trees had deadwood removed, pruned for aesthetic and structural purposes, and were entered into the City's plant healthcare program.
- August 5: City Contractors pruned and maintained trees at Grace Park.




